

Wetslip Meeting Exchange List Rules

From the rules (13.A.3):

The date the written requests are received by the Harbormaster shall establish priority. Anyone who fails to be represented at the annual slip assignment meeting or otherwise declines to accept a slip offered for lease shall be stricken from his or her respective list and must submit a new request. Members are allowed only one slip.

Currently the way the slip exchange list is maintained is that your position on the list is determined by the date you request to be on the list. At the meeting, if you elect not to take another slip when your name comes up, your position stays at that position on the list as based upon the date you first made your request to be on the list. If you do elect to exchange your slip, it is interpreted as that you have taken another slip and your name is removed from the list. So, in order to be placed back on the list, you must submit another **written** request to be placed back on the list. As a convenience, if you request to “remain on the list” at the slip meeting, we waive the necessity of submitting your request in writing, but your request is considered a **new** request and you then drop to the bottom of the exchange list. Of course, if other people after you on the exchange list, exchange as well, they also will drop to the bottom of the list, so you maintain your priority, as in regard to them, on the list.

Members that already have a permanent slip assignment may NOT take a sublease slip. This violates the one member, one slip rule above. If you do decide to take a subleased slip, you give up your permanent slip and start over on the bottom of the waiting list.

Waiting List

Members on the waiting list are processed after members on the exchange list.

Your priority on the waiting list is also determined from the date your request is received. If you join the Association with a large boat, we will usually, but not always, add your name to the waiting list effective your membership date.

In lieu of taking a permanent slip assignment from the slips available, you may elect to take a sublease slip. If you decide to take a sublease slip, your name will also be dropped from the waiting list and you will need to submit another request in writing to be reinstated on the waiting list. Again, as a convenience, if you request to “remain on the list” at the slip meeting, we may waive the necessity of submitting your request in writing. Either way, your request is considered a **new** request and you then drop to the bottom of the waiting list.

We will attempt, as a courtesy, to add your name to the exchange list, when you take a permanent slip assignment, but it is best always to submit your request in writing.



